



Learning German is important for everyone!

You will be able to communicate better in German – with the authorities, at school, at the doctor's or with your social worker. In particular, women who speak German can make many trips on their own: to kindergarten, to school, to the women's club. When the children are in kindergarten or school, mothers have time for a language course. The children also learn German in kindergarten and are well prepared for school.

There are various German courses in Dresden, for example integration courses (including learning to write), youth integration courses and vocational language courses.

Some courses can also be attended part-time.

Those entitled to participate in **integration courses** are:

- People with a residence permit, regardless of country of origin, good prospects of staying or date of entry
- Holders of a residence permit in accordance with § 104c AufenthG (Opportunity Residence Permit)
- Holders of a tolerated stay permit in accordance with § 60a(2) sentence 3 AufenthG
- Holders of a residence permit in accordance with § 24 or § 25(5) AufenthG
